#### 2 Purpose

This document summarises the progress made to date in securing IPR agreements with data providers to allow inclusion of rights protected works in the BHL-Europe portal, expanding the corpus of content. It also aims to articulate the process for the addition of further material.

#### 3 Agreements to use works protected by copyright

The majority of digitised biodiversity literature made available by project partners is sufficiently old to be no longer protected by copyright. The scientific, historic and cultural value of this older literature is significant. However the Project Management Group recognise that making more recent works available through the BHL-Europe portal would hugely benefit the scientific community in particular. Works published after 1910, which are identified as 'high risk' in the project's IPR Best Practice Guide, require explicit permission from rights holders to a) allow their digitisation and storage on project servers, and b) for the works to be made available under a Creative Commons licence. Rights holders have a legitimate economic interest in controlling access to, and re-use of such works. Consequently, the Project Management Group acknowledge the challenge faced by project partners to persuade rights holders to allow these works to be made freely available on the world wide web under an irrevocable, relatively permissive licence. Project partners must be advocates of the Creative Commons licensing framework in order to secure copyright protected works for inclusion in BHL-Europe.

#### 3.1 Rights clearance

The Project has used three approaches to tackle rights clearance to date.

- 1 Work Package 2 has identified new content providers who are also rights holders and secured permissions directly. The project has successfully negotiated agreements with the Gesellschaft für Biologische Systematik<sup>2</sup> (GfBS) and the Institute of Paleobiology of the Polish Academy of Science<sup>3</sup> for contribution of the following titles:
  - ➤ Acta Palaeontologica Polonica Vol. 1 Vol. 55 (Institute of Paleobiology of the Polish Academy of Science)
  - Organisms Diversity & Evolution Vol. 1 Vol. 9 (GfBS)
- 2 Existing project partners have licensed content to which they own the copyright.

As rights clearance is subject to the resource constraints of project partners, a pragmatic approach has emerged from some project partners to first digitise public domain works, followed by works for which their own institution owns the rights and where their institution is willing to license the works under a Creative Commons licence.

3 – Existing project partners have cleared permissions with third party rights holders. The activities of Work Package 2 in compiling and de-duplicating a comprehensive library catalogue from all partners have helped prioritise titles and publishers/rights holders to begin rights clearance.

#### 3.2 Addition of further material

Work Package 2 has a list of potential content providers whom it is assumed are also likely to be rights holders for the content they hold. If approaches by Work Package 2 are successful, any involvement of these content providers in the project would require assent to the Memorandum of Understanding which stipulates the Open Access terms (specifically a Creative Commons licence) under which content would be licensed. The benefit of this approach is that such content providers own rights to large bodies of content, making rights clearance more efficient.

Work Package 2 is also collaborating with all project partners to establish a collections development policy to articulate how to organise content contribution and prioritisation of content for BHL-Europe. Partners are contributing to this discussion on the BHL-Europe project wiki. The Collections Development Policy will take account of various prioritisation issues such as the quality, theme, preservation urgency and subject matter of works. The ease of rights clearance is also a clear consideration as any prioritisation is subject to the legal obligation not to infringe third party intellectual property rights. The Content Development Policy will be further defined at the annual review meeting in Tervuren in June 2011.
